RMHH Holcombe House is a 50-bedroom facility located within a mile of the Texas Medical Center that offers out-of-town families inexpensive lodging while their children are receiving in-patient and outpatient treatment at Texas Medical Center. Each family has a private bedroom and bath. The Holcombe House also offers a large communal kitchen, living and dining room, laundry facilities, a playroom, game room for teenagers, outdoor play areas, television and quiet rooms, Internet service so that families can stay in touch with other families and friends back home. The Holcombe House fulfills the RMHH mission by providing comfortable, home-like environments that encourage caring and sharing among families whose children are seriously ill. Parents and children find mutual comfort and support from other families who are experiencing similar situations. RMHH provides its services at little to no cost to lessen the stress and some of the financial burden associated with a serious illness. Volunteers actively participate in the delivery of services to the families by checking families in and out; interacting with the families; providing meals and family activities, both on and off site, and assisting with fundraisers. Additionally, the Holcombe House offers a special needs kitchen for organ and bone marrow transplant patients as well as weekday shuttle service to/from the Texas Medical Center medical institutions and area shopping. School age children are able to keep up with their studies at the on-site schoolroom operated in conjunction with the Houston Independent School District.

The TCH House provides families with the comfort and support of a home-like environment steps away from their child's treatment area. RMHH also operates four Family Rooms in different locations throughout the TCH facilities. These are located in (1) the Cancer Outpatient Clinic, (2) the inpatient oncology/hematology floor, (3) the Cardiovascular Intensive Care Unit and, (4) the Pavilion for Women. Each Family Room offers a quiet sitting area, dining tables, television, snacks, fresh coffee, and periodic meals provided by volunteers. The Family Rooms allow parents to stay close to their child and have an area for a quiet moment of respite.

The RMHH services inside the Children's Memorial Hermann Hospital (CMHH) include a 14-bedroom/private bathroom house that offers overnight and napping accommodations at no cost to families while their children are being treated in the Intensive Care Unit. The CMHH House offers a kitchen, dining area, lounge, library/computer station, television, snack pantry, and laundry facility. The CMHH House also offers 7 Care-by-Parent Rooms. This program allows parents to spend several days with their ill child as they prepare to transition from the hospital to the home setting. Parents receive one-on-one care instructions from their CMHH medical team as to the care the child will need at home.
